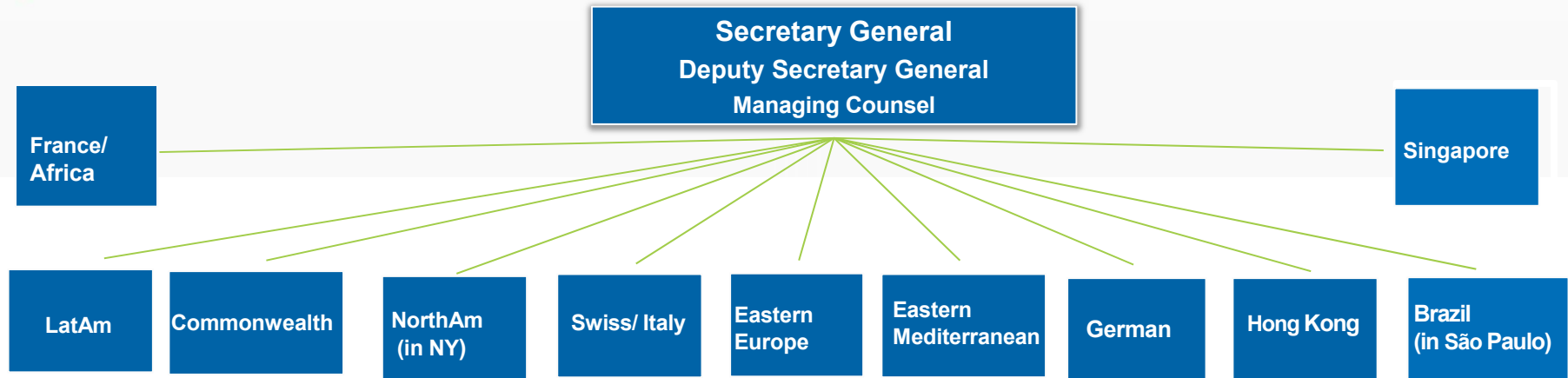

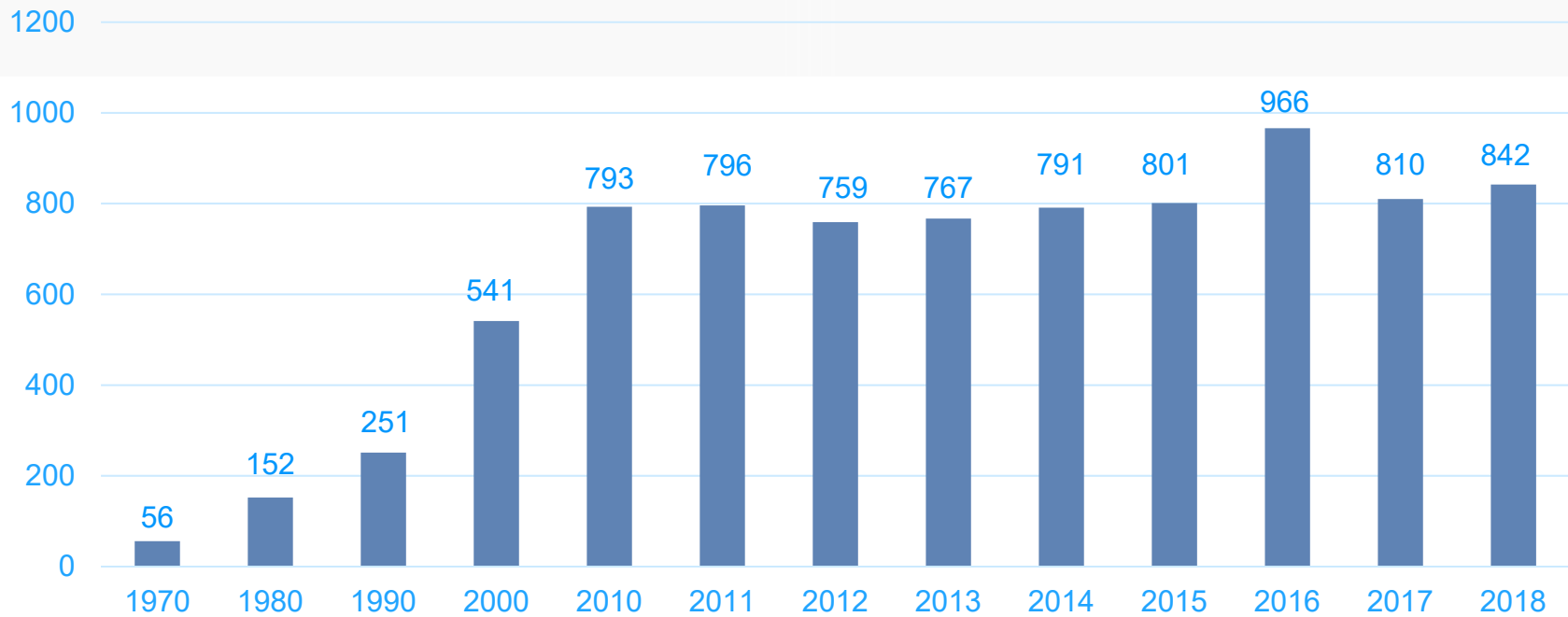

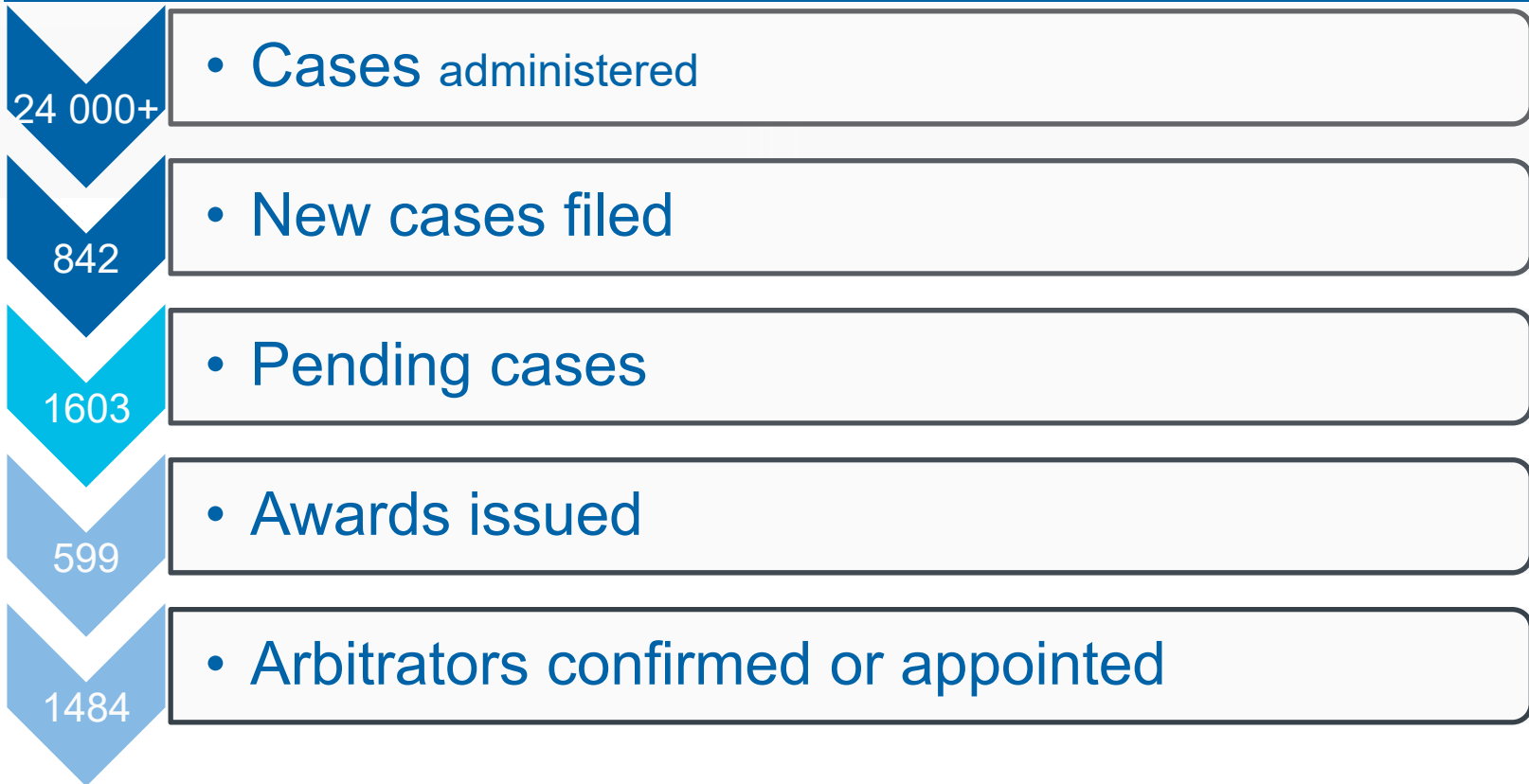

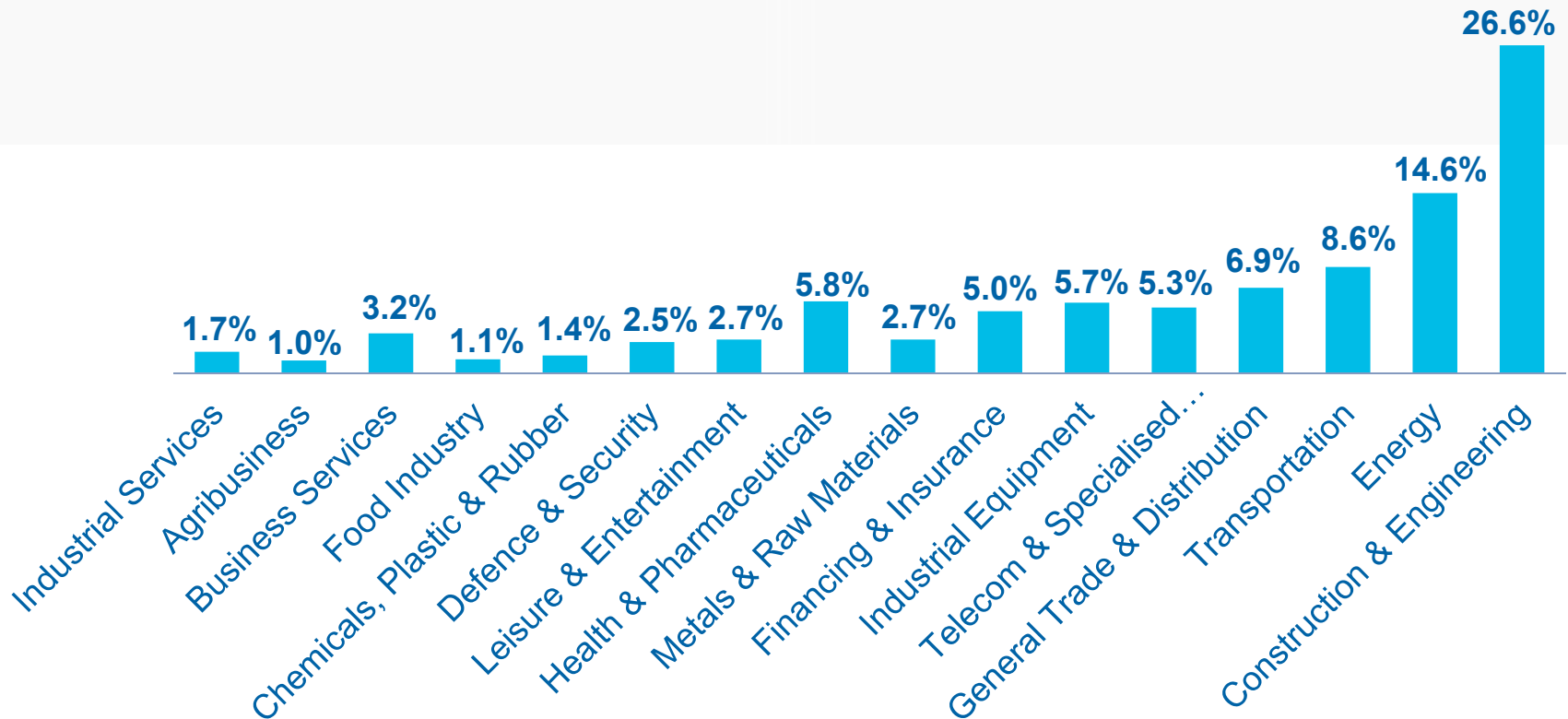

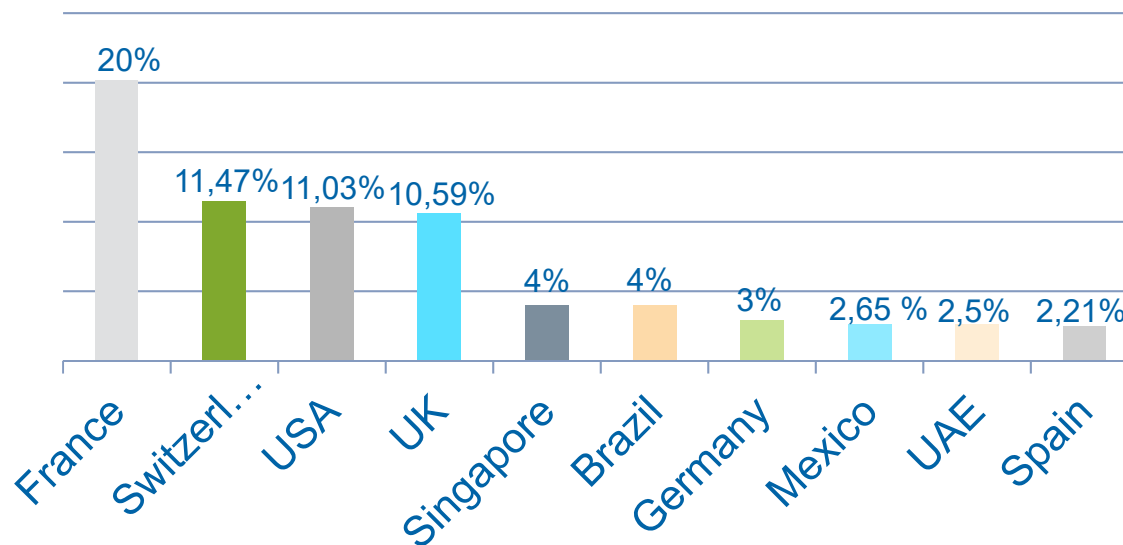

- Ranking of top 10 countries

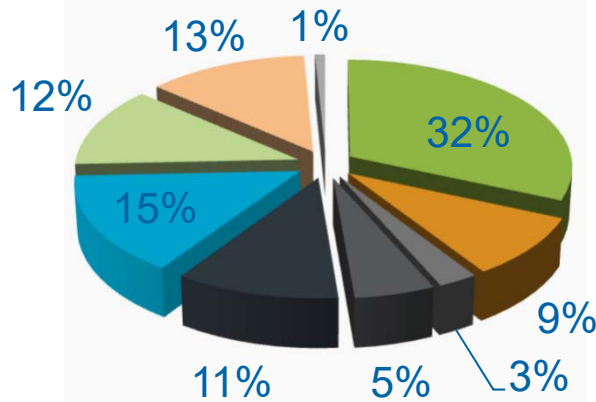

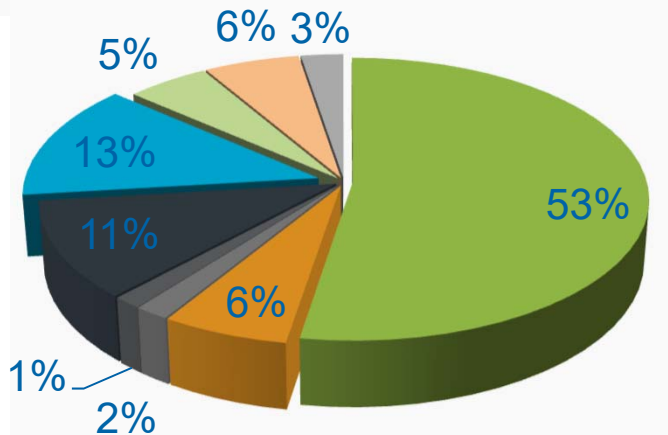

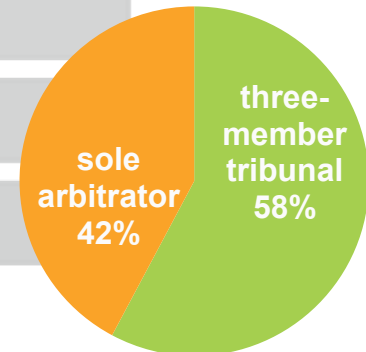

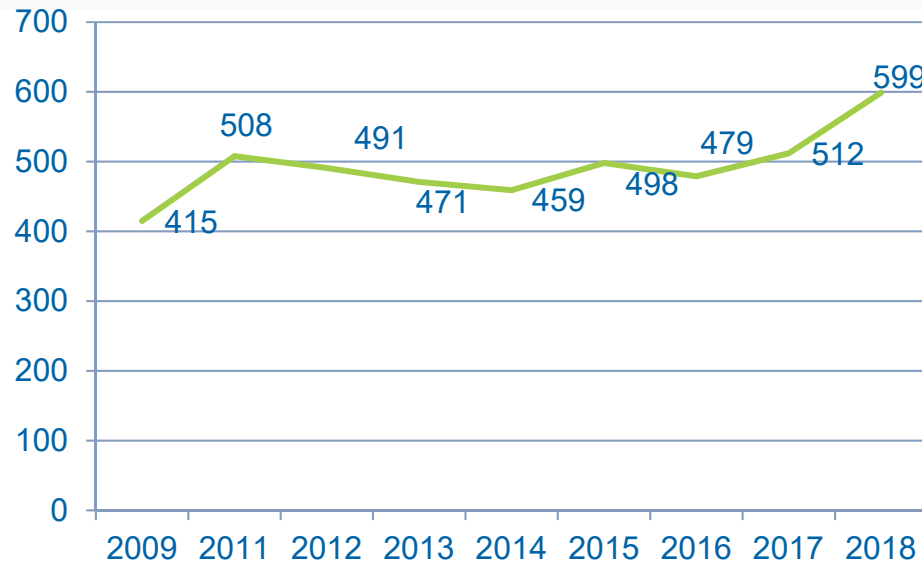


2018 Very slight drop in party nominations

Trend in number of awards approved by year

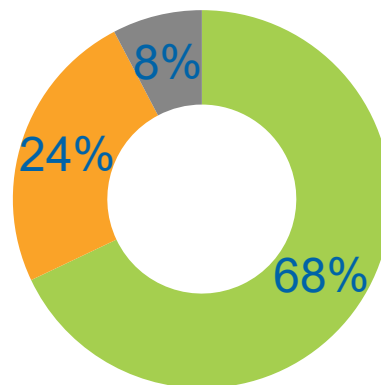

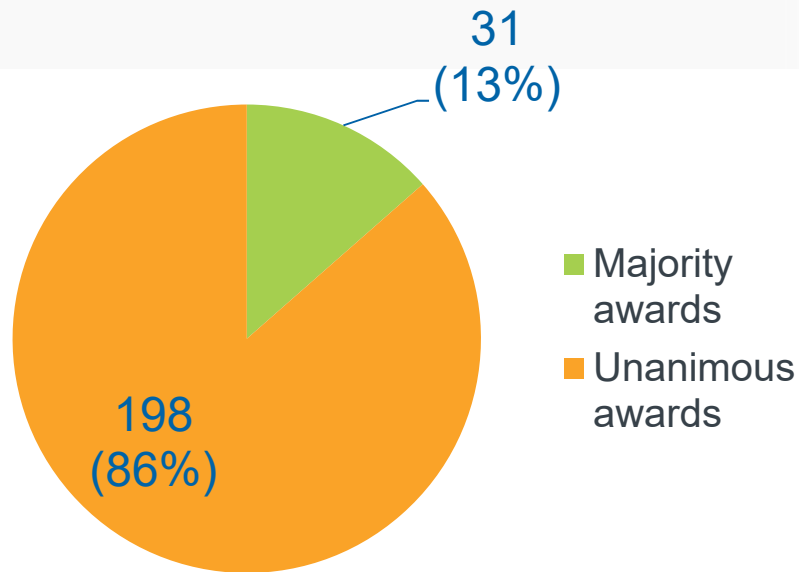
- ▶ 599 awards approved

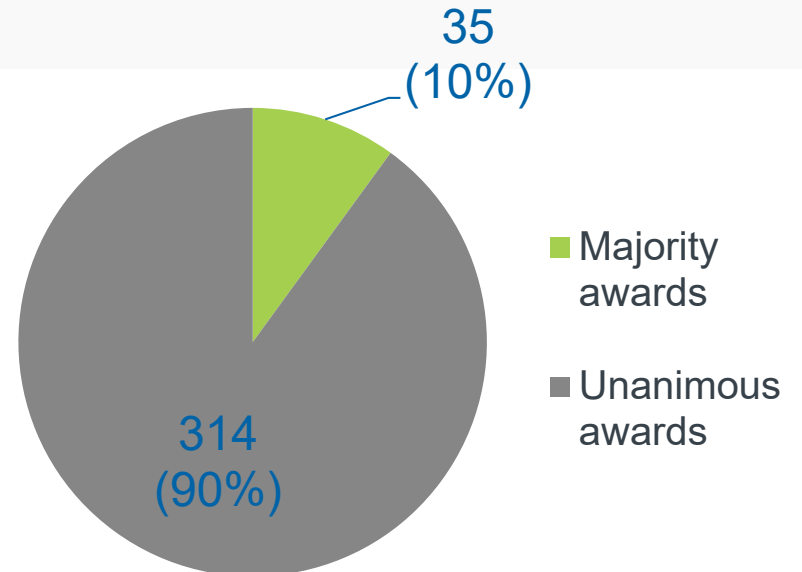
