Pulitzer Prize-winning journalist and bestselling author James B. The author of 11 books, Stewart's *New York*Times bestseller, *DisneyWar*, about Michael Eisner's reign at the company, won the Gerald Loeb Award for Best Business

Book. *Heart of a Soldier* was named the "Best Book about 9/11" by *TIME* magazine. His other bestsellers include *Blood*Sport and *Den of Thieves*, the definitive account of 1980s Wall Street insider trading scandals.

Stewart's latest book, *Tangled Webs: How False Statements are Undermining America: From Martha Stewart to Bernie Madoff,* analyzes America's perjury trend, which he suggests is symptomatic of an ethical breakdown compromising the country's judicial system as well as business, government, academia and medicine.


