- 9:10 – 10:25 a.m. **The Not So Secret Law of Trade Secrets: How to Keep ‘em and What To Do When You Lose ‘em**
(1.5 credits in Professional Practice)
Until the recent enactment of the federal Defend Trade Secrets Act, employers in New York State had limited access to the federal courts when their trade secrets were misappropriated. The DTSA changed that in dramatic fashion because it allows employers to file a civil suit in federal court for theft of trade secrets and obtain injunctive relief against the misuse of those secrets, as well as damages and attorneys’ fees. In extraordinary circumstances, a court may order the ex-parte seizure of trade secrets by law enforcement to prevent their propagation or dissemination. While non-competes and breach of non-solicitation cases will continue to be litigated primarily in state court, trade secret litigation may now shift to the federal courts.
- Our panel of experts will examine the issues of how to protect your secrets and what to do if they are misappropriated. Discussed will be the application and use of the DTSA, the Computer Fraud and Abuse Act, and New York common law. The panel’s goal is to provide information about these statutes laws, review best practices with regards to workplace confidentiality policies, and how and in what forum to prosecute your claim and the relief you can expect.
