### **T. David Stapleton Memorial Scholarship**

The New York Bar Foundation is pleased to announce the **2022 Elder Law and Special Needs Section T. David Stapleton Memorial Scholarship** which has been established by The Foundation through a gift from the Elder Law and Special Needs Section of The New York State Bar Association. The Section is pleased to offer this Scholarship in honor of former Section Chair, T. David Stapleton. The scholarship, with a value of \$2,500, will be awarded to a second year (2L) or third year (3L) law student who is enrolled in a law school in the State of New York in one of the following regions: Central New York, Finger Lakes, Southern Tier and Western New York who has a demonstrated interest in the Elder Law and Special Needs practice areas and has clear plans to practice in the field in one of these regions following law school, or a law student that is from this region, studying at a law school outside the region, who has clear plans to return to the region to practice Elder Law.

T. David Stapleton practiced in Auburn, NY and served as NYSBA Elder Law & Special Needs Section Chair from 2011-2012, after having followed the officer track and being involved in leadership within the Section leading up to such role. David not only led as a tremendous lawyer, but he also advocated for “upstate” involvement, sought to expand our knowledge of literature by peppering almost every writing and conversation with a poignant quote, encouraged a healthy lifestyle through diet and exercise and demonstrated the importance of family, friends, and camaraderie among lawyers.

David’s signature issue during his tenure as Chair was the expansion and rescinding of expanded Medicaid estate recovery. Some will recall his having mentioned that while he understood the underlying concept of the state in seeking to expand recovery options, he truly believed the powers-that-be did not appreciate the devastating impact it would have on the “little folks” who would lose even modest inheritances if the expansion was carried out.

While not diminutive in stature, David always diminished his breadth of knowledge of the law, often calling himself a “small, upstate lawyer.” It is our honor to offer this scholarship in his name to another potential “small, upstate lawyer” in David’s memory.

#### **The T. David Stapleton Memorial Scholarship Goals**

The ultimate goal of the scholarship is to create a network and cultivate relationships among lawyers whose practice focuses on elder law and special needs planning and law students planning to practice in these areas to encourage the practice of elder law and special needs planning among lawyers in the upstate regions of Central New York, Finger Lakes, Southern Tier and Western New York.

### **The T. David Stapleton Memorial Scholarship**

The scholarship, valued at \$2,500, will be awarded to one (1) student enrolled on a full-time or part-time basis during the 2021-2022 academic year in a law school in the State of New York in one of the following regions: Central New York, Finger Lakes, Southern Tier and Western New York who has a demonstrated interest in the Elder Law and Special Needs practice areas and has clear plans to practice in the field in one of these regions following law school, or a law student that is from this region, studying at a law school outside the region, who has clear plans to return to the region to practice Elder Law.

1. The Elder Law and Special Needs Section Scholar will be a guest member of the NYSBA Elder Law and Special Needs Section during 2022.
2. The Elder Law and Special Needs Section Scholar and a guest will be invited to attend The Elder Law and Special Needs Section's Annual Meeting in January 2022, to receive the award.
3. The scholarship recipient will be announced in December 2021.
4. The Elder Law and Special Needs Section Scholar will be selected by a committee comprised of representatives from The New York Bar Foundation and the NYSBA Elder Law and Special Needs Section. The selection committee will be comprised of no less than three members of the Elder Law and Special Needs Section.

### **Eligibility**

1. The scholarship is open to all second-year (2L) and third-year (3L) students who are enrolled in a law school in the State of New York in one of the following regions: Central New York, Finger Lakes, Southern Tier and Western New York who has a demonstrated interest in the Elder Law and Special Needs practice areas and has clear plans to practice in the field in one of these regions following law school, or a law student that is from this region, studying at a law school outside the region, who has clear plans to return to the region to practice Elder Law.
2. The student must have attained a 2.5 or equivalent GPA in law school.
3. A preference will be given to a student who can demonstrate financial need.

### **Payment of Scholarship**

The scholarship will be applied to the student's 2021-2022 academic year tuition. A check, made payable to the law school and the student, will be sent to the school no later than the end of February 2022.

## **Scholarship Application Requirements**

**The applicant must submit the following in PDF format:**

1. A completed application (application form below).
2. Cover letter of interest.
3. Unofficial law school transcript.
4. Current Résumé
5. A five-page double-spaced essay by the student demonstrating why he or she would like to practice in the areas of Elder Law or Special Needs Planning in the Central New York, Finger Lakes, Southern Tier and Western New York region.

## **Deadline**

All materials must be submitted by email on or before **Wednesday, December 1, 2021.**

## **Judging**

Criteria for judging applications will be:

1. Content and quality of application materials.
2. Demonstrated interest in Elder Law Elder Law and Special Needs Planning.
3. Academic record.
4. Recommendation from advisor or another relevant individual.
5. Quality of written expression.
6. Maturity, integrity, and professionalism.
7. Any other relevant factors.

## *About T. David Stapleton*

Community leader and attorney, T. David Stapleton was a founding member of the firm Karpinski & Stapleton, P.C. and a native of Auburn, NY. He practiced law for more than 50 years--first with his father-in-law, John J. Karpinski, and then with his brother-in-law, John A. Karpinski. Mr. Stapleton served Cayuga County as an Assistant District Attorney, and then focused on Estates and Trusts for many years. His legal acumen earned him admission to argue before the Supreme Court of the United States of America. His true legal passion emerged in the second half of his career when he focused on Elder Law and became the first attorney in the Cayuga County area to do so. Mr. Stapleton's dedication and determination to care for the elderly and those with special needs quickly earned him peer



recognition. Mr. Stapleton was asked to serve on the Executive Committee of the Elder Law Section of the New York State Bar Association. He served in numerous capacities, including as Chair ("Antique" Chair, as he jokingly referred to himself) of the 3,000-member Section where he continued to advocate for the elderly and those with special needs. He worked tirelessly lobbying lawmakers and changing New York State law while sharing best practices in the field. For his efforts and expertise in Elder Law, he received numerous awards, including Best Lawyer and Super Lawyer. Mr. Stapleton also volunteered his time to ensure that the elderly in Cayuga County knew best how to protect themselves and their life's savings.

Mr. Stapleton served on numerous boards and committees in the local community including the Seward House Museum Foundation, United Way, Cayuga Community College Foundation, Auburn Community Hospital, Cayuga County Chamber of Commerce, Auburn Bicentennial Committee, Auburn Field the Dream Campaign for Falcon Park, and Cayuga County/City of Auburn Cooperative Governance (Chair).

Mr. Stapleton graduated from Catholic University Law School and Georgetown University. He was a man of great intellect and integrity who was blessed with an abundance of humor and selflessness.
