1. <u>Approval of December 2022 Meeting Minutes</u> – Isaro Carter, Secretary; Ethan Bordman, Chair; Christine-Marie Lauture, Asst. Secretary

The EC unanimously approved the December EASL Minutes. Judy Bass asked whether the executive committee meeting on January 4<sup>th</sup> would have minutes distributed. It was confirmed that the minutes are being written up.

2. EASL Journal status (Elissa Hecker)

Elissa Hecker reported that the latest issue is almost done. The deadline for the summer issue isn't set in stone yet. Elissa urged committee chairs to encourage their members to contribute to the next issue.

#### 3. Financial Report (Judah Shapiro, Treasurer)

Judah Shapiro reported that we still have a surplus of over \$100K; we anticipate having more regular activity, so it will likely go down. Judah also reported that Albany approved the budget.

Judah informed the EC that the most considerable expense would be the publications & again, money will be spent, but thankfully, we have it. Ethan Bordman also mentioned that some money is coming in from the membership dues. It was also noted that those who don't renew by April would be dropped from our Membership.

Barry Skidelsky inquired about the number of members as of Dec 31<sup>st</sup>. Judah didn't have that info on hand but said he'd give Barry a call about it. Ethan asked Judah how much money is allocated to each committee, as the Law Student Committee wanted to know. Judah responded that \$750 is given to each group. Kathy Kim interjected to recommend that we double-check to be sure this amount was accurate.

# 4. Committee/Program Reports/Updates (ad hoc)

- Cowan/Bresler Scholarship Committee Kajon Pompey and Aniqa Chowdhury Congratulations, Winners!
  - Kajon & Aniqa were not present at this EASL EC meeting, but Ethan reported that they would be present at our section's annual meeting to receive their EASL Scholarship awards. These two winners were from St. Johns and Fordham Law Schools, respectively. Ethan thanked our scholarship committee chairs for the great job they did, noting that this year we had 16 papers from 8 different law schools.

- Talent Agencies Act of New York Approved by NYSBA
  - Ethan reported that NYSBA had approved the EASL report recommending legislative action drafted by the Legislative Committee (previously circulated to the EC for approval). The next steps are for NYSBA (specifically Leanne Evans, NYSBA's Government Relations Policy Manager) to submit the proposal to the NY State Assembly (Bill Drafting Commission).
- Theatre Committee
  - Jason Baruch updated us on a program on March 8<sup>th</sup> that his committee has planned with the Dramatists Guild. The publicity will be going out in the next week.
  - Jason also reported that the CTI Program is effectively discontinued. Still, the committee is reworking a new program that allows for a program every three months instead of an 8-hour program over two nights. Not a hybrid event; it is in person.
