Rafael has taught as a visiting professor at Harvard, Columbia, the University of Texas, the University of Puerto Rico; CIDE and !TAM in Mexico, and served as visiting scholar at the Wilson Center (Washington, DC) and other US and Latin American academic institutions. Rafael has published widely on Cuban and U.S. policies, inter-American relations, international security, human rights, migration, as well on Cuban culture and civil society.

Option/TRACK 1: ERNEST HEMINGWAY TOUR

10:30 a.m. - We travel to the picturesque fishing village of Cojimar. Ernest Hemingway loved this little seaside town. He kept his boat, El Pilar, in the harbor of Cojimar, and he used this village setting for his story The Old Man and the Sea, which won him the Nobel Prize for Literature in 1954.

After enjoying a quick cocktail in Cojimar, we continue to Lunch at Paladar II Divino.

After lunch, we travel to **Finca Vigia**, Ernest Hemingway's home in **San Francisco de Paula**. The home contains original furniture, artwork, personal memorabilia & other objects collected by the author. Of special importance is the author's library containing thousands of irreplaceable letters & telegrams, photographs, scrapbooks, manuscripts, & galley proofs.

Return to Havana. Remainder of afternoon/evening free.

Option/TRACK 2: FARM VISIT / LAS TERRAZAS

We depart for **Finca Villa Hortensia**, a farm in the Artemisa province (APPROX. 50-minute drive) to learn about sustainable agriculture in Cuba.

After our farm visit, we travel to the pioneering eco -community of **Las Terrazas in Sierra del Rosario**. This biosphere came under UNESCO protection in 1984 due to the success of the reforestation project. It is now home to 117 bird species, including 12 that are endemic. During our visit to Las Terrazas, we see the ruins of a **French Coffee Plantation** built in 1801 by the French who escaped Haiti after the 1791 Haitian revolution.

Lunch at **Cafetal Buenavista** or **El Campesino** at Las Terrazas.

After lunch, we continue for a guided tour of the Village of Las Terrazas including a visit the famous **Cafe Maria** for delightfully rich Cuban coffee. Here you may also have the opportunity to purchase locally grown/roasted Cuban coffee.

Return to Havana. Remainder of afternoon/evening free.

Dinner on your own. Optional evening entertainment: Tropicana Night Club or Havana Queens Show.

Anti-Money Laundering and Combatting Terrorist Financing: The Cuban Regulatory Framework

We'll then delve into international anti-money laundering conventions and their incorporation into Cuban domestic law, covering key agreements such as the Vienna Convention, Palermo Convention, Merida Convention, FATF Standards, and UN Conventions. The program will also offer a comprehensive examination of Cuba's regulatory framework, including relevant decree laws, resolutions, and penalties outlined in Cuban law. Finally, we'll discuss due diligence measures and best practices in Anti-Money Laundering to ensure compliance and efficacy in combating financial crimes.
