## **KEYNOTE SPEAKER:**

### **Senator Steve Geller, Esq.**

**Broward County Commissioner/Former Florida Senator, Geller Law Firm, PA, Fort Lauderdale, Florida**

Senator Steve Geller is currently a Broward County Commissioner, having been elected to represent District 5 in 2016. District 5 consists of all or part of Cooper City, Southwest Ranches, Davie, Plantation and Sunrise. Geller serves as Chairman of the Broward County Water Advisory Board, Chairman of the South Florida Regional Planning Council, Chairman of the Economic Development District for South Florida of the Economic Development Agency of the U.S Department of Commerce, Chairman of the Community and Urban Affairs Committee and on the Executive Committee of the Florida Association of Counties, and serves on the Broward County Cultural Council. Geller's top priority is bringing highly paid jobs to Broward County.

Geller was elected to the Florida Legislature in 1988, at the age of 29. Geller served in the Florida Legislature for 20 years, 9 in the House, and 11 in the Senate. Geller was appointed a Committee Chair by both Democratic and Republican Presiding Officers. Geller served two terms as Chair of the Broward County Legislative Delegation. When he retired from the Senate because of Term Limits, Geller was the Minority (Democratic) Leader of the Florida Senate. Geller was also elected as National President of two Different Legislative organizations, the National Conference of Insurance Legislators (NCOIL), and the National Council of Legislators from Gaming States (NCLGS).

Geller currently runs Geller Law Firm, where he practices primarily in the areas of Gaming Law and Zoning and Land use. He is an "A-V" rated lawyer, and has been listed in "South Florida's Top-Rated Lawyers", "Florida's Super Lawyers", and the "Bar Register of Preeminent Lawyers". He has received dozens of awards, including the Senator of the Year Award from the Florida League of Cities, the Lifetime Achievement Award from the Florida Association of Counties, the Legislator of the Year Award from the Florida AFL-CIO and the Florida Chapter of the American Planning Association, as well as Legislative awards from the Police Benevolent Association, the Professional Firefighters, and numerous Union and attorney groups. He served as the Chairman of the Board of the Holocaust Documentation and Education Center.

Geller was born in New York, New York, in 1958. He has lived in South Florida since 1965. He attended Florida State University for college and law school, where he was a member of AEPi Fraternity. He has lived in South Broward since his graduation from Florida State University College of Law in 1982. He is married to Laurel Geller, and they have two children, Marc Geller and Ben Geller.

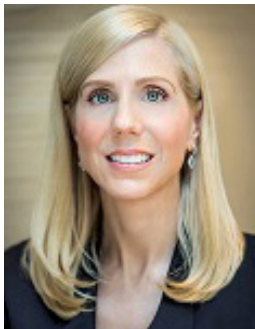

Judge James G. Clynes was elected to the Civil Court of the City of New York, New York County on November 7, 2017, and took office on January 1, 2018. Judge Clynes is currently assigned to the New York State Supreme Court, New York County as an Acting Justice of the Supreme Court.

Prior to joining the bench, Judge Clynes served as a Nassau County Assistant District Attorney in the felony trial bureau. He then became a trial attorney with the Nationwide Insurance Company, litigating personal injury and property damage cases. Then he served as the principal law clerk to New York State Supreme Court Justice Alexander M. Tisch.

Judge Clynes received his Bachelor of Science degree, cum laude, from Villanova University in 1981, and his Juris Doctor degree from the University of Notre Dame Law School in 1984.

Judge Clynes is a member of the New York State Bar Association Torts, Insurance & Compensation Law, Trial Lawyers and Judicial Sections.



## **Prof. Patrick M. Connors**

**Albert and Angela Farone Distinguished Professor in New York Civil Practice, Albany Law School, Albany, New York**

Patrick M. Connors is the Albert and Angela Farone Distinguished Professor in New York Civil Practice at Albany Law School where he has taught New York Practice and Legal Ethics since 2000. Commencing with the January 2013 supplement, Professor Connors became the author for the treatise Siegel, New York Practice. The publication's sixth edition, "David D. Siegel & Patrick M. Connors, New York Practice (6th ed. 2018)," was released in March, 2018. The treatise has been cited in thousands of reported decisions and has been called "The Bible" for litigation in New York State courts.

He received his B.A. degree from Georgetown University and his J.D. degree from St. John's University School of Law, where he was an editor of the Law Review and research assistant to Professor David D. Siegel. Upon graduation from St. John's in 1988, Professor Connors served as a personal law clerk to Judge Richard D. Simons of the New York Court of Appeals until 1991. From 1991 until May of 2000 he was an associate and then member of the litigation department at Hancock & Estabrook, LLP, in Syracuse, New York.

Professor Connors is also the author of the McKinney's Practice Commentaries for CPLR Article 22, Stay, Motions, Orders and Mandates, Article 23, Subpoenas, Oaths and Affirmations, Article 30, Remedies and Pleading, and Article 31, Disclosure. He also authored the Practice Commentaries for the former New York Rules of Professional Conduct and several articles in the Surrogate's Court Procedure Act. He is currently an author of the New York Practice column and the annual Court of Appeals Roundup on New York Civil Practice, which are published in the New York Law Journal. From 1992 through 2003, he was a Reporter for the Committee on New York Pattern Jury Instructions ("PJI"), the panel of New York State Supreme Court Justices that drafts and oversees the frequent revisions of the standard jury charges in civil cases. His publications have been cited in hundreds of reported cases.

He was a member of the New York State Bar Association's Committee on Professional Ethics from 1996 through 2016. He served on the New York State Attorney Grievance Committee for the Fifth Judicial District from 1997 until 2000. He was the Reporter for the New York State Bar Association's Special Committee on the Code of Judicial Conduct, which published a report recommending substantial amendments to New York's Code of Judicial Conduct. Later, Silver became an equity partner in the newly-formed firm of Fields, Silver & Santo, L.L.P.

Silver is the recipient of several awards and accolades and is involved in many community-based and Bar Associations including the NAACP, New York State Bar Association, The Puerto Rican Bar Association and the Jewish Lawyers Guild. Silver is also a highly sought-after trainer and speaker on topics relating to mediation and the emerging field of alternative dispute resolution within it.

- Lifeguards are only on duty from Memorial Day weekend through Labor Day weekend.
- Dogs are allowed on the beach of N. 10th Street and south of S. 10th Street
- Bonfires are permitted only during the months of November-April due to Sea Turtle nesting season .
- Dodge the dunes: Only access the beach using the approved stairs and access points.  
Do not walk, slide, jump or throw items down the dunes.
