- 4. Report of Treasurer. Mr. Yanas' report, copies of which previously had been furnished to all members of the House, was received with thanks.
- 5. Amendment of Bylaws of the Real Property Law Section.
 Martin A. Shlufman, Secretary of the Real Property Law Section, summarized the proposed amendments to the section's bylaws. Upon motion, the following amendments were approved:

ARTICLE IV, Nomination of Officers. Section 1. 7. Report of Special Committee to Study Alternative Sources of Funding for New York Legal Services Council. Justin L. Vigdor, Chairman of the Special Committee to Study Alternative Sources of Funding for New York Legal Services Council, summarized the significant portions of the Special Committee's report as presented at the January meeting. He then reviewed the Special Committee's recommendation for establishment of a voluntary program to utilize interest earned on lawyer trust accounts to fund civil legal services programs in New York State and provide financial resources to improve the administration of justice. Mr. Vigdor also described the endorsements given the proposal by governmental and legislative leaders, as well as numerous bar associations in New York State. Following discussion, a motion was adopted approving the following resolution:

RESOLVED, that the House of Delegates of the New York State Bar Association hereby recommends, in principle, as proposed by the Special Committee to Study Alternative Sources of Funding for New York Legal Services Council, the establishment of an Interest on Lawyer Trust Account Program in the State of New York, with participation by attorneys to be on a voluntary basis; and it is further

RESOLVED, that the officers of this Association are hereby authorized and directed to take any and all necessary action to achieve the approval of the Legislature of any statutes required in their judgment to implement this statement of policy.

- 8. Recognition of those responsible for production of Juror Orientation Film. Hon. Nat H. Hentel, Chairman of the Committee on Courts and the Community, presented an award of special recognition to Mrs. Evelyn Sharp for her financial assistance to the juror orientation film entitled "Trial by Jury A Partnership for Justice," which had been screened at the January meeting. Awards of recognition were then presented to Mary Lou Crowley, Hon. Norman Goodman, Hon. Irving Kirschenbaum and John C. Maloney for their significant contribution to the development and production of the film.
- 9. Presentation of Trial Lawyers Section National Trial Advocacy Competition Awards. Anthony J. DeMarco, Jr., Chairman of the Trial Lawyers Section Committee on Trial Advocacy Competition, Presented the Trial Lawyers Cup and Scholarship to Syracuse University College of Law as the New York State law school placing highest in the National Trial Advocacy Competition. Mr. DeMarco also Presented certificates of merit to Albany Law School in recognition of that school's second place finish in regional competition.

- 10. Report regarding Proposed Code of Evidence for the State of New York. Following review and discussion of comments submitted by sections and committees concerning the "Proposed Code of Evidence for the State of New York," as drafted by the New York State Law House that the matter requires further study and that a special committee be appointed for this purpose.
- International Trade Commission's General Procedures for the Conduct of Investigations. Robert L. Geltzer, Chairman of the Corporate Counsel Section, reported concerning the section's request that the Association endorse the position taken by the American Bar Association that Section 207.7 of the International Trade Commission's General Procedures for the Conduct of Investigations be amended to avoid discrimination against corporate counsel. Following discussion, the following resolution was adopted.

RESOLVED, that the New York State Bar Association and its Corporate Counsel Section endorse the Resolution of the American Bar Association urging amendment of Section 207.7 of the International Trade Commission's General Procedures for the Conduct of Investigations and communicate their support to the Congress, the International Trade Commission, the American Bar Association and other interested parties.

12. <u>Presentation of Award of Merit by Special Committee</u> on Lawyers and the Community. Thomas M. Whalen, III, Chairman of the Special Committee on Lawyers and the Community, presented the Award of Merit to the Monroe County Bar Association for distinguished professional and public service accomplished through its Long-Range Planning Forum conducted in October 1982.

13. Report of Chairman.

- a) Mr. Fales announced that bar associations entitled to delegates had filed their designations of delegates for the year 1983-1984. On motion, said designations were approved as filed, and a further motion was adopted approving the filed roster of members of the louse as the official list for 1983-1984.
- b) Pursuant to request by Mr. Fales, and upon motion adopted by the House, the terms of the following special committees were extended for an additional year:

c) It was then announced by Mr. Fales that the New York County Lawyers' Association was celebrating its 75th anniversary. 14. Report of President. Mr. Reilly reported the following

- c) The Association had engaged in an extensive and successful effort to defeat expansion of the state sales tax to include attorney's fees. Mr. Reilly expressed his appreciation to the officers, the members of the House, and representatives of county and local bar associations for their support and cooperation in this matter.
- d) Following consultation with interested groups within the Association, legislation had been filed to ameliorate the effects of the Barasch/Eaton decisions governing law office failure. He noted that alternative proposals had been submitted by other interested groups, including the Office of Court Administration, and that the Legislature currently had these under consideration.
- e) He had urged the Governor and legislative leaders to enact the Office of Court Administration budget at the submitted level, but the budget had been reduced in spite of this request. Mr. Reilly indicated that the officers would continue to encourage government leaders to separate the judiciary budget from other fiscal concerns to ensure adequate funds and judicial resources to address calendar congestion effectively.
- f) The Committee on Group and Prepaid Legal Services Plans was progressing in its efforts to facilitate the establishment of open panel legal insurance plans, and that major insurance carriers had become actively involved in the development of programs suitable for marketing in New York State.

15. New business.

- a) Andrew M. Schnier, Chairman of the Criminal Justice Section, described the effect of legislation introduced to restrict the role of counsel in the voire dire process. He reported concerning the position taken by the Criminal Justice Section, and endorsed by the Association Executive Committee, that the present system of lawyer participation in voir dire be retained. Following discussion, a motion was adopted that the Association support the continuation of voir dire by counsel in all litigation in the State of New York.
- b) Richard G. Compson, Delegate from the Oneida County Bar Association, reported concerning the status of pending legislation which would significantly alter the current manner in which medical malpractice cases are litigated. Following discussion, a motion was unanimously adopted that the Legislature be requested to postpone action on the proposed medical malpractice legislation until the Association has had the opportunity to present its position.
- 16. <u>Date and Place of Next Meeting</u>. The next meeting of the House of Delegates will be held on Saturday, June 25, 1983 at The Otesaga, Cooperstown.

MEMORIAL GIVEN BY MR. BENJAMIN N. HEWITT IN MEMORY OF FORMER NEW YORK STATE BAR ASSOCIATION PRESIDENT, CLARENCE R. RUNALS, AT THE 106TH ANNUAL MEETING OF THE ASSOCIATION, APRIL 22, 1983

Clarence Ryder Runals, President of the New York State Bar Association in 1957, died on March 12, 1983 in Tucson, Arizona after a brief illness.

"Spike" as he was known to his many friends throughout the State was born on a farm in Arcade, New York in 1893, graduated from the Law School of the University of Buffalo in 1916 and commenced practice shortly thereafter in Buffalo. In 1919 he came to Niagara Falls, became a partner in the City's largest firm and continued to practice actively with that firm and its successors until 1982. He was considered a giant among the lawyers in Western New York, but still he always had time to counsel and help younger lawyers.

Throughout his practice he was active in Bar Association affairs. In his younger days, along with the late Robert Jackson of Jamestown, Lewis Ryan of Syracuse and others, he worked diligently with Upstate lawyers to persuade them to transfer some of their interests from their District Federations and to come back into the State Bar Association. Without those efforts, of which most lawyers here are probably unaware, the New York State Bar Association would not be the great statewide Bar Association that it is today.

He was a delegate to the State Constitutional Convention in 1938, the recipient in 1970 of the outstanding alumni award of the University of Buffalo and a Fellow of the American College of Trial Lawyers.

He is survived by his widow, Edith Runals, of Niagara Falls, his son, John E. Runals, with whom he practiced law for many years, two daughters, seven grandchildren and ten great grandchildren.
