How to Enter:

1. **Eligible articles** must be written by a currently-enrolled or graduating student at a New York State Law School or by a New York State resident at any ABA-accredited law school outside of New York State.
2. **Eligible papers** include notes, comments and articles and should generally be 20-30 pages in length, with footnotes. In no event may papers exceed 50 pages, with footnotes.
3. **Eligible papers** may address any topic of general interest to the antitrust law community, including topics relating to civil and criminal antitrust law, competition policy, consumer protection, and international competition law
4. Jointly prepared papers are **not eligible**.
5. Go to the Antitrust Law Section on the NYSBA website and click on the "Awards, Fellowships & Scholarship" section and then scroll down to "Writing Competition. Download an Entry Form.
