What will I get from participating?

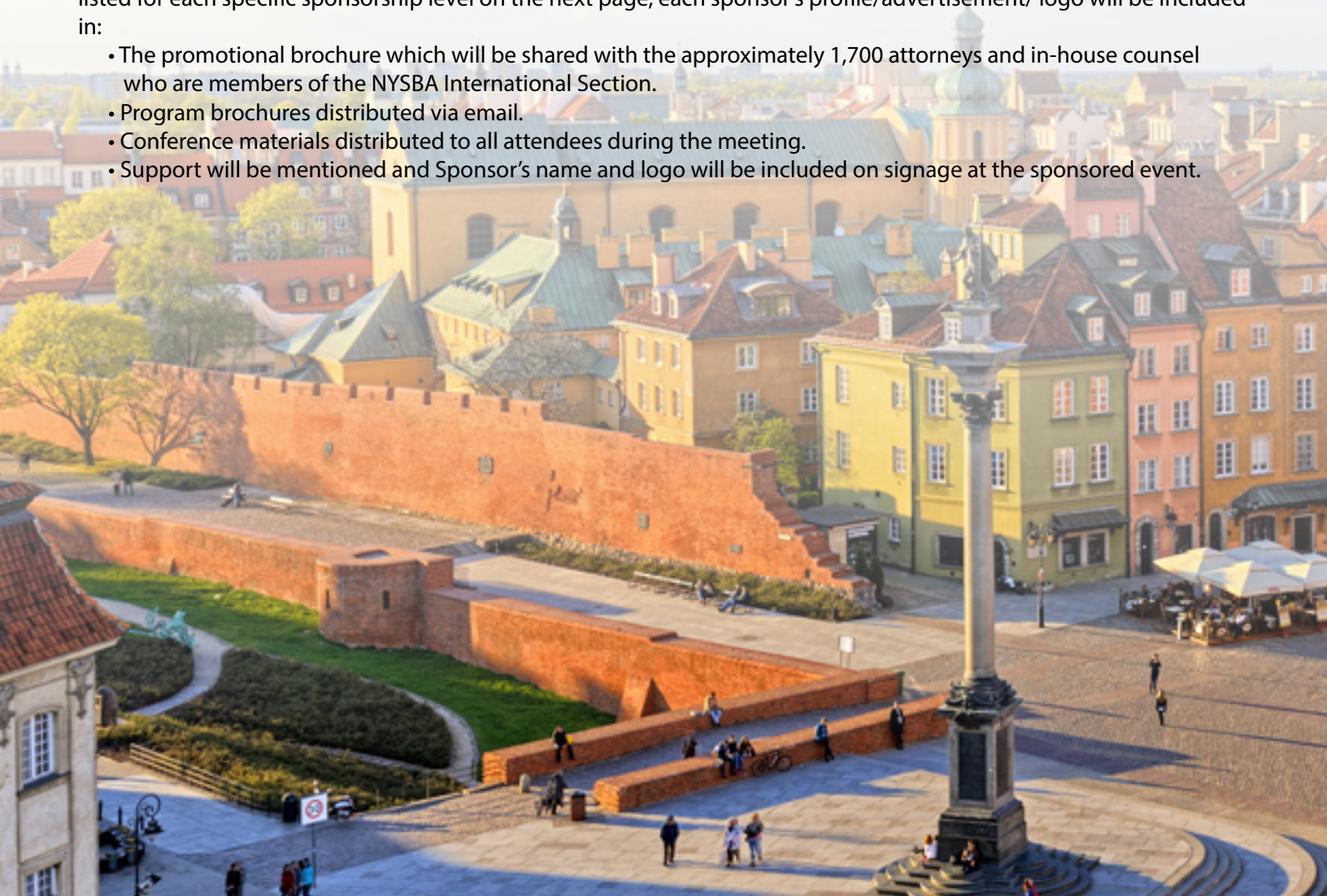
The Spring Meeting offers participants opportunities to:
