The Fellowship is a one (1) year appointment, and affords Fellows the following opportunities:

- Access to Trusts and Estates Law Section Executive Committee meetings during the year of the Fellowship.
- Placement on a committee and an opportunity to attend regular committee meetings.
- Work with a committee chair or vice-chair as a designated mentor to help develop a topic for an article to be published in the TELS journal or speaking topic to be presented on at a TELS continuing education seminar .
- Waived registration fee to the Annual Meeting during the year of the Fellowship and the year following the Fellowship.
- Waived registration fee to the Spring Meeting and Fall Meeting during the year of the Fellowship.
- Reimbursement of certain travel expenses for the Spring Meeting and Fall Meeting during the year of the Fellowship and the Annual Meetings during the year of the Fellowship and the year following the Fellowship.
